Dear Returning Applicant,

In keeping with our commitment to education, First Baptist Church of Glenarden (FBCG) offers continuing financial support to FBCG financial assistance recipients. Since you previously were awarded financial assistance from FBCG, you are eligible to renew your application for assistance if you meet the following guidelines as well as submit the required paperwork by the **April 29, 2019** deadline:

Guidelines

- **Active in a ministry or Christian activity (see mandatory verification form attached)**
- **Enrolled full-time in an undergraduate degree program in a university, college, or community college for the 2018-2019 academic year**
- **Under 23 years of age as of June 22, 2019.**
- **A member of First Baptist Church of Glenarden**
- **2.5 Cumulative Grade Point Average (GPA) or higher (you are ineligible for renewal if your GPA is below 2.5)**

Required Documents for a complete application

- **Completed and signed Returning Student Financial Assistance Application**
- **Completed Ministry Involvement Verification Form(s)** This includes active membership in a FBCG ministry, campus based ministry, or Christian outreach activities. Ministry Involvement will be evaluated based upon your **active service to others** through a FBCG ministry, campus based ministry, or Christian outreach activities. Active membership indicates participation and volunteerism or service provided to the church community or any church or college chapel activity. Participation in social groups, organizations, or non-Christian based groups that provide service to the community will not be accepted.
- **Completed Financial Aid Notification Form that you and your parent/guardian sign**
- **An official transcript that contains your cumulative GPA at the end of the Fall 2018 semester/quarter. Please note that an additional final transcript that contains grades for the spring 2019 semester/quarter must be submitted by June 22, 2019.**
- **An enrollment verification form from your school's Registrar's Office or other appropriate office.**
- **First page of your most recent Student Aid Report (SAR) from FAFSA**

Disqualification/Forfeiture of Financial Assistance Award

The following actions will result in the forfeiture/revocation of your FBCG financial assistance award:

- Willfully giving false information.
- Failure to submit **ALL** required documentation by the deadline.
- Misuse of prior year funds. (Any funds not used for designated purpose **MUST** be returned to FBCG.)
- **Failure to enroll and maintain status as a full-time student.**
