Required Documents for a complete application

- Completed Ministry Involvement Verification Form(s) This includes active membership in a FBCG ministry, Christian campus-based ministry, or off-campus Christian ministry during the 2023-2024 school year. Ministry Involvement will be evaluated based upon your active service to others through a FBCG ministry, campus based ministry, or off-campus Christian ministry. Active membership indicates participation and volunteerism or service provided to the church community or any church or college chapel activity. Participation in social groups, organizations, or non-Christian based groups that provide service to the community will not be accepted.
- Completed Financial Assistance Notification Form that you and your parent/guardian sign
- An <u>official</u> transcript that contains your <u>cumulative</u> GPA at the end of the <u>Fall 2023</u> semester/quarter. <u>Please note that an additional final transcript that contains grades for the spring 2024 semester/quarter must be submitted by June 17, 2024.</u>
- An enrollment verification form from your school's Registrar's Office or other appropriate office/clearinghouse.
- Your 2024-2025 Student Aid Index (SAI) printout from your FAFSA Submission Summary.

Disqualification/Forfeiture of Financial Assistance Award

The following actions will result in the forfeiture/revocation of your FBCG financial assistance award:

- Willfully giving false information.
- Failure to submit **ALL** required documentation by the deadline.
- Misuse of prior year funds. (Any funds not used for designated purpose MUST be returned to FBCG.)
- Failure to enroll and maintain status as a full-time student.
